Hall County 2023 Property Taxes Due by Nov. 15

'Save a Trip, Skip the Line' with convenient ways to pay your taxes

GAINESVILLE, Ga. (Nov. 1, 2023) — As the Nov. 15 property tax deadline approaches, the Hall County Tax Commissioner's Office is reminding taxpayers that there are several convenient options to pay taxes to save time and avoid traveling to the Tax Office.

"We've been working for a long time on creating multiple ways for taxpayers to pay their taxes without coming in our door," said Hall County Tax Commissioner Darla Eden. "Today, about the only reason for visiting our office is to make a cash payment."

Through a newly redesigned website and other communications, the Tax Commissioner's Office has been educating the public about the ease of paying taxes as part of its "Save a Trip and Skip the Line" campaign. Making online tax payments at **hallcountytax.org** is easy, safe, and convenient. Online payment methods include E-Check (\$1.50 flat fee), debit card (1.99% transaction fee) and credit card/PayPal, PayPal Credit (2.5% transaction fee). All major credit cards are accepted. The PayPal Credit payment option is a line of credit that is interest-free after the initial transaction fee if paid in full within the sixmonth window. Terms and conditions apply.

Another option is payment by mail, using the return envelope provided with the statement sent to your address on file. Send your check or credit card info to P.O. Box 1579, Gainesville, GA 30503. Payments must be postmarked by Nov. 15 to avoid state-mandated interest charges.

Taxpayers can use the drive-up drop box available 24/7 located across from the front doors at the Hall County Government Center under the breezeway at 2875 Browns Bridge Road. Payments must be placed in the drop box on or before Nov. 15 to avoid state-mandated interest charges.

The Tax Office can accept payment via debit and credit card through our Customer Interaction Center, where helpful agents are available Monday through Friday, and 8 a.m. to 5 p.m. To make a payment or get assistance, please call 770.531.6950, text 833.602.8497, or email propertytax@hallcounty.org.

In-office tax payments paid in cash are accepted in the lobby of the Tax Office. Payments by check or card are accepted at the Information Desk, where you can request a receipt by mail or email. To minimize your wait, please contact our Office or go online to make an appointment.

Property owners on January 1 are responsible for that year's property tax. For properties sold in 2023, buyers and sellers must determine who will pay the tax by the November 15 deadline. Refer to your closing documents or attorney to determine tax liability and ensure on-time payment to the Hall County Tax Commissioner's Office.

"Our office is dedicated to offering a range of payment options that cater to our community's needs," said Eden. "I encourage property owners to utilize our many convenient tools to save a trip and skip the line."
