Hall County Tax Commissioner Adds Vehicle Tag Renewal Kiosk at Thompson Bridge Kroger

GAINESVILLE, Ga. (March 2024) – The Hall County Tax Commissioner's Office has opened a new self-service vehicle tag renewal kiosk inside the Kroger store at Thompson Bridge Commons on Thompson Bridge Road.

It is the first tag kiosk in North Hall County and the northernmost one in the state.

"Located in a highly traveled area, the Thompson Bridge Kroger kiosk is a convenient location for our North Hall residents," Hall County Tax Commissioner Darla Eden said. "One of the key advantages of the tag renewal kiosks is they are open when the store is open which is beyond normal business hours for most. That gives you more chances throughout the day or weekend to renew your tags and print your decals. All you need is your driver's license, renewal notice, or tag number. Scan, pay, and print. It's that easy."

The kiosk will be open during the store's operating hours from 6 a.m. to 11 p.m. The machines accept credit or debit cards and include a convenience fee of \$3.95 for up to 10 renewals. The tag renewal machines have gained popularity throughout Hall County because of their availability, efficiency and ease of use.

With the opening of the Thompson Bridge Kroger kiosk, located at 3630 Thompson Bridge Road in Gainesville, Hall County citizens now have access to four self-service kiosks conveniently located in area Kroger stores. The other three kiosks are situated at 1931 Jesse Jewell Parkway in Gainesville, 7380 Spout Springs Road in Flowery Branch, and 4025 Winder Hwy. in Flowery Branch.

Citizens are encouraged to take advantage of this convenient option for renewing their motor vehicle tags. The Tax Commissioner's office offers several ways to "Save a Trip and Skip the Line" to handle motor vehicle and property tax payments.

- Renew tag decals and pay property taxes online at www.hallcountytax.org.
- Instant tag decals at kiosks in participating Kroger stores.
- Mail in tag renewal or property tax payment.
- Use the drive-up drop box just across from the front doors at the Hall County Government Center.
